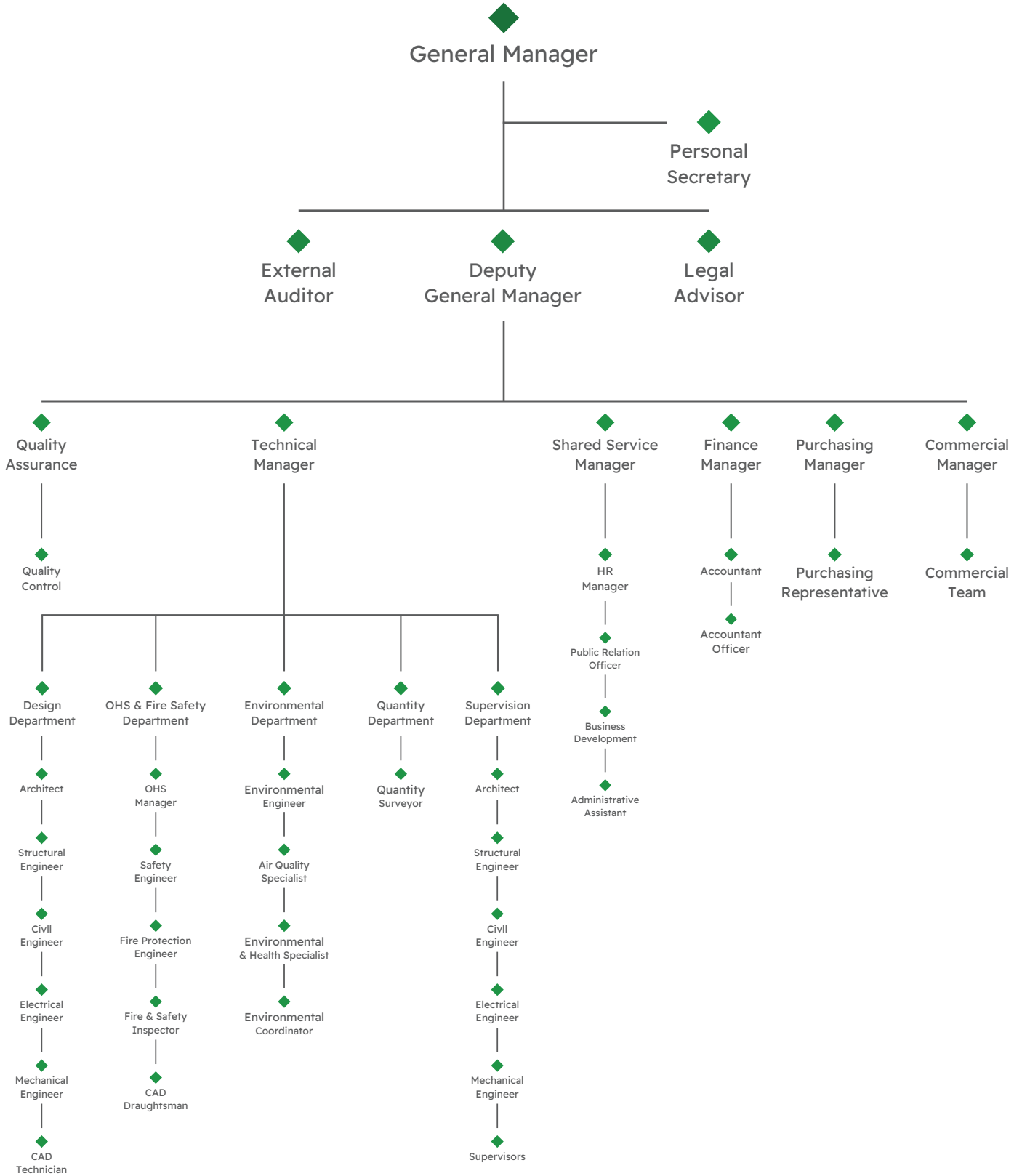

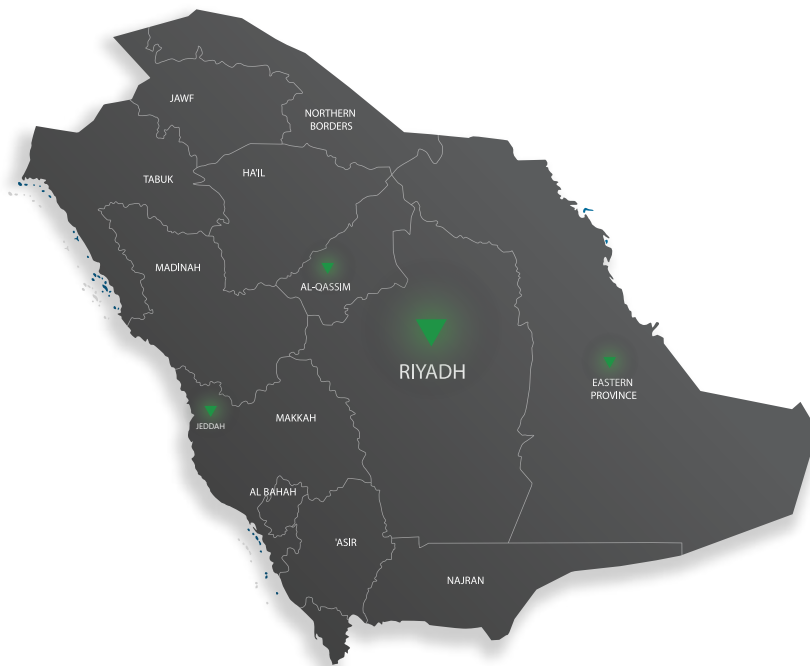
ORGANISATION CHART

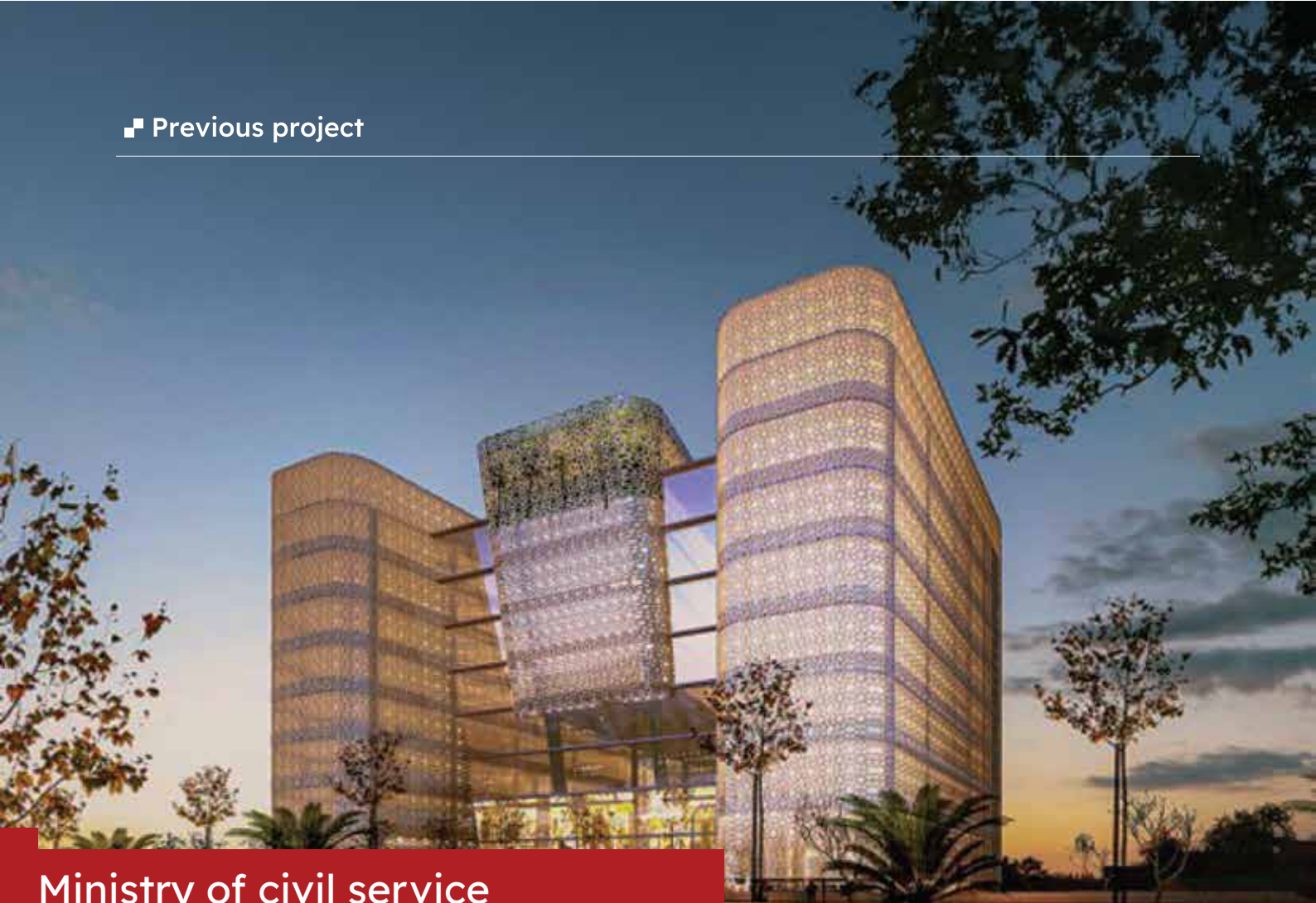

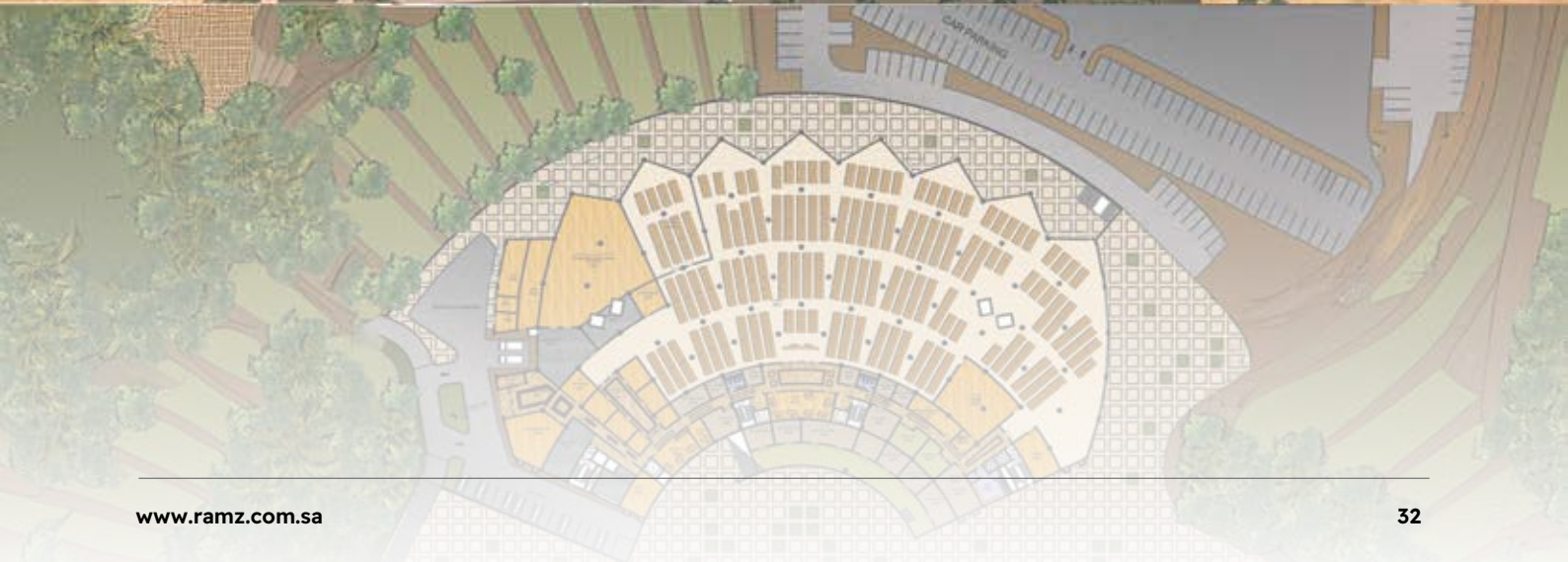
